



# Australia Travel Declaration – question set from 10 Dec 2021

## What is changing?

The Australia Travel Declaration has been available to travellers since 4 November 2020. All travellers to Australia (excepting flight crew and foreign diplomats) are requested to complete the Australia Travel Declaration.

As part of the broader usage of the Australia Travel Declaration, the questions are continually refined to improve useability and to meet usage requirements of the Australia Travel Declaration. Below is a list of all questions that could be asked of a traveller. Note that in most instances they will not have to answer all questions, as a number of questions are dependent upon responses provided by the traveller to previous questions in the declaration.
